FENLAND AERO CLUB SAFETY MANAGEMENT POLICY MEMBERS AIRSIDE SAFETY RULES

Fenland Aero Club has a **Safety Management** policy; this policy is set out in the Fenland Aerodrome Manual (a copy of which printed overleaf). There are risks associated with operating and visiting 'Airside¹' on any airfield, principally involving proximity to moving aircraft and the limits to visibility associated with aircraft operations and design. The following rules apply to all members (Flying and Social) of the Fenland Aero Club. You are required to read and sign indicating that you have understood the said rules, and return this form to the Club Secretary.

Personal Safety:

- Many aircraft and helicopters have only a limited view from the pilot's seat. Be aware that they might not be able to see you;
- If you have to approach an aircraft try to make sure that you stay within sight of the pilot (the pilot of a
 fixed-wing aircraft normally sits on the left seat and the pilot of a helicopter sits in the right seat); never
 approach an aircraft from the rear and keep away from engines, propellers etc even if you think that
 the aircraft is not in operation;
- No member of the public (non-members) will be allowed airside unless accompanied;

Driving Safety:

- At no time shall any vehicle (other than Emergency and Grass Cutting Vehicles) drive airside on the apron, taxiways, runways, manoeuvring or aircraft parking areas unless permission along with specific instructions has been given by the CFI / Airside Manager / ATC when manned;
- All persons wishing to access the area of the New Hangar with a vehicle to load or unload from an
 aircraft or to undertake maintenance on an aircraft etc., then the vehicle must remain on the paved
 concrete area. Any barrier or gate opened to allow a vehicle through into the said area must be closed
 as soon as the vehicle has passed through, failure to do so could result in the driver being refused
 permission thereafter;

Aircrew & Passenger Safety:

- All pilots will be responsible for the safety to and from their aircraft (when airside) of any persons accompanying them;
- Stay with your guide they may know a lot more about the dangers than you do;
- Do not climb onto any aircraft, or touch any part of it; panels are very thin, and sometimes are just painted cloth;
- If walking under a high-wing aircraft, keep clear of struts, fuel-drain vents and pitot tubes (sharp pointed tubes that work the airspeed indicator);
- The safest place to approach on most aircraft is just between the wing and the tail-plane;
- Keep looking all around you walk, never run;
- Keep clear of propellers on fixed-wing aircraft they can start unexpectedly if turned;
- Look out for helicopter rotors, especially the tail-rotor like propellers, rotors can easily kill;
- If someone shouts 'Clear Prop', it means they are about to start the engine keep away;
- Fuelling aircraft with passengers on board (they must be off loaded) is strictly prohibited;

Foreign Object Debris (known as FOD) - is any loose item / rubbish on an aerodrome, which could be a danger to aircraft engines, airframes & flight operations. **It is essential** that the airside (but also the Clubhouse & car parking) is a clean and FOD free environment. Please pick up any litter (it is **FOD)** to help prevent damage to aircraft and general flight safety.

Accident and Incident Reporting

Your duty as a member is to report unsafe or dangerous practice. This can be done anonymously if you wish.

Any member of Fenland Aero Club who has significant safety concerns about any part of the aerodrome operations or any Club safety issues should approach the CFI or any committee members with their concern.

All such incidents must be recorded on a safety form.

Safety Report forms are available in the clubhouse by the signing in desk. Completed forms should be passed to the CFI.

Safety forms will subsequently be reviewed by the CFI and if necessary, by the safety committee each month.
